Provided you and your correspondent have examined the documents detailed herein with reasonable care to ascertain they appear on their face to be in accordance with the terms and conditions of the credit, we expressly discharge you and your correspondent of any liability or responsibility of the form, sufficiency, accuracy, genuineness, falsification or legal effect of any documents; or for the general and / or particular conditions stipulated in the documents or superimposed thereon; and of any liability or responsibility for the description, weight, quality, condition, packing, delivery, value or existence or the goods represented thereby, or for the good faith or acts and/or omissions, solvency, performance or standing or the consignor, the carrier or the insurers of the goods or any other person whomsoever.

In case insurance is to be covered by us, we undertake as soon as we are informed of the exact shipment date, to remit to you the insurance policy or certificate made to your order. Consequently, our insurer is authorized to remit directly to you the funds payable by him under the said policy, these funds will be allocated to the repayment of all funds paid by you, including your charges, fees and commissions as well as those claimed by your correspondent.

It is hereby agreed that the goods herein specified and supporting documents are hypothecated to you as collateral security for the due payment of the negotiations effected in accordance with the terms and conditions of the present letter of credit. In case the value of the goods hereby hypothecated as collateral security comes to the insufficient for any reason whatsoever, we undertake to remit to you an amount equivalent to difference between the amount of this credit and the said value of the goods.
